GENERAL CONDITIONS 2018

Each candidate is invited to complete and return to the Club an admission form, duly signed by two sponsors, together with one photograph. The candidature is then considered by the Committee.

Following a positive response from the Committee, the applicant will dispose of one month to accomplish the following formalities:

A. FULL MEMBER

1. The purchase of a bond issued by the ASBL GOLF CLUB DE SEPT FONTAINES.
This bond is transferable at the best convenience of the member.
Cost of the bond linked to the market.
2. Payment of the entry fee: 1.000 €.
3. Payment of the subscription:

B. USAGER

In addition to the above-mentioned statute, the holder of a bond can confer the right of use, against payment or free of charge, to any other person. This right of use is conferred for an indefinite period.

The holder of the mandate will then pay the entry fee, without exemption for people under 35 years old, and annual membership subscription as outlined in point A.

F. BUSINESS CLUB IN COLLABORATION WITH B19 BRUSSELS

A new formula launched this year will enable members of 7 Fontaines Golf Club who are also members of the B19 Country Club "*The 21st Century Business Club*" to :

I. DISCOVER GOLF

→ **High Season (March to October)**

For a period of 6 months, we shall present the different aspects of golf, and allow you to familiarise yourself with the sport.

For a subscription of **550 €**, you will be provided with:

- Access to the driving range and pitch & putt (pro's agreement)
- loan of golf club, a warranty of 300 € is required
- 10 private practical lessons (1/2 hour)
- 'rules of golf' booklet
- Inscription to the examination “Brevet d’aptitude” (aptitude certificate)

In case of membership as a Full Member, a reduction of 550 € is applied on the entry fee.



→ **Low Season (November to February)**

For a period of 4 months, we shall present the different aspects of golf, and allow you to familiarise yourself with the sport.

For a subscription of **400 €**, you will be provided with:

- Access to the driving range and pitch & putt (pro's agreement)
- loan of golf club, a warranty of 300 € is required
- 10 private practical lessons (1/2 hour)
- 'rules of golf' booklet
- Inscription to the examination "Brevet d'aptitude" (aptitude certificate)

In case of membership as a Full Member, a reduction of 400 € is applied on the entry fee.

J. LOCKERS

Golf bags can be stored in a special depot with access limited to occupants. For increased security, individual lockers are available for an annual fee of 80 € (small) or 100 € (large).

The storage area in the basement of the Chateau, provides individual golf bag and trolley lockers with electricity for battery charging at an annual cost of 215 €.

Individual lockers for personal effects are also available in the changing rooms of the Club House for an annual fee of 60 €.

K. FEDERATION FEE & CLUB HOUSE

The Golf Federation fee (compulsory) is **52 €** for adults and 10 € for juniors under 21 years of age.

We also ask each temporary member to leave a deposit of 35 € for the trolley tag and for an access card. We shall repay the amount when the temporary member leaves the club and returns the tag, or when the temporary member becomes a full member.

A 100 € deposit will be asked to add on your personal account at the Club House. This deposit is compulsory for each householder more the 24 years old.

L. PARTNERSHIPS

The Golf Club 7 Fontaines has been cooperating with a sport and leisure Club named "David Lloyd Brussels". As a member of our Golf Club, you can benefit there from special conditions on your membership.

Temporary memberships are limited to a one-year period. Memberships are not refundable.
